July 7 "Walt Whitman, Gay Icon and American Visionary" by Thom Botsford, retired professor of English and UUCP Member

Before the words "gay" and "homosexual" were common names for samesex attraction, the 19th century poet Walt Whitman was celebrating male "friendship" and "adhesion" in *Leaves of Grass*. A new collection of his love poems, *Live Oak with Moss*, marks the poet's 200th birthday and helps us appreciate his radically inclusive vision of America.

July 14 "Puja—The Hindu Worship Ceremony" Dr. M. Lal Goel, retired professor and UUCP Member

Dr. Goel will perform the Hindu worship ceremony known as Puja. The ceremony consists of the offering of flowers, incense and light to a chosen deity, either male or female. Chanting of a prayer and of sacred mantras accompanies the service. A food item that has been offered to the Divine and is thus sanctified (prasad) is then distributed to the congregation. *This is a Service for All Ages*.

July 21 "The Problem with Plastic" Dr. Enid Sisskin of UWF

Dr. Sisskin has been a local environmental activist for the past 26 years and has worked as a researcher at the National Institute of Environmental Health Sciences, at Everglades National Park, was a Lecturer at the UWF Dept. of Public Health and is now a Research Associate in the Biology Department there. She produces the daily EcoMinute on WUWF Public Media. Her presentation will discuss the many problems with plastic. There are potential human health concerns and serious environmental issues. Most shorebirds and various other marine organisms have plastics inside them. We can reduce the amount of these types of plastics reaching waterways by using less and disposing of them properly.

July 28 "Remember the Bossa Nova" A special music service with singer Rosie Butler, guitarist Walt Kattner, saxophonist and UUCP Member Thom Botsford and friends.

In 1962 saxophonist Stan Getz and guitarist Charlie Byrd recorded *Jazz Samba* in Pierce Hall, an acoustically superior space in the All Souls Unitarian Church of Washington D.C. To everyone's surprise, the record was a big hit, spending 70 weeks on the Billboard Top LP chart and marking the beginning of a trend and dance craze. Nearly sixty years later, our music program will try to re-create the delicate instrumentation and lightly swinging sound of Getz, Byrd, and singer Astrud Gilberto, the voice of "The Girl from Ipanema."

Aug. 4 "The Super Power of Resilience – Watch the Bouncy Ball" by Trista Blouin of Guardian ad Litem and UUCP Member

Trista Blouin will share how important resilience has been throughout her life and in the lives of those she has encountered in her work as a photographer and in the Guardian ad Litem Program.

Certainly the price couldn't be beat and the food was tasty (with a little soy sauce). The affair was nicely topped off by a cake from chief organizer Georgieanna Bryant. There were about 12 of us plus Flo and an equal number of her family and friends.



Film Showing: UUCP Sanctuary When They See Us Part 1 July 17 Wednesday 6pm

When They See Us is based on events of the 1989 Central Park jogger case and explores the lives of the five suspects who were prosecuted on charges related to the sexual assault of a female victim, and of the boys' families. The five juvenile males of color were divided by the prosecutor into two groups for trial. Each youth was convicted by juries of various charges related to the assault; four were convicted of rape. They were sentenced to maximum terms for juveniles and the one adult, Korey Wise, (who was 16 at the time of the crime), had been held in adult facilities and served his time in adult prison.



After the assailant was identified in 2002 by confession, DNA evidence, and other evidence in an investigation by the DA's office, he requested that the court <u>vacate</u> the convictions of the five men (a legal position in which the parties are treated as though no trial has taken place). By that time, all the men had served their sentences. The state withdrew all charges against them from the 1989 case and removed them from the sex offender registry.

STRIVE FOR JUSTICE



UUJF July 2019 Newsletter—UUA General Assembly 2019, Spokane, WA June 19-23

Our main purpose at GA was threefold:

- 1. Thursday: to update the Draft Statement of Conscience (SOC), which is the concluding document with recommendations for next steps following the 2016-2020 Congregational Study/Action Issue "The Corruption of Our Democracy." At the Mini-Assembly we offered numerous amendments that had been drafted by a team including UUs Michael Greenman of Columbus, Ohio; Joan Marshall of All Faiths Unitarian in Ft. Myers, Florida; Anne Burnham, of UUs of Clearwater, Florida, Greg Coleridge of the Move to Amend Coalition, and Michael Bleiweiss of the Ethical Society of New York City. A key focus was the proposed 28th "We the People" amendment to the U.S. Constitution.
- **2. Friday:** to pass the updated SOC at the full assembly Friday with the link to the **Move to Amend Interfaith Caucus**. This caucus is reaching out to all faiths to address the existential threat of climate change.
- **3. Friday, Saturday and Sunday:** to reach out to UU congregations all over the country to sign up for information needed for their congregation to pass a resolution for Move to Amend, and encourage their members and interfaith colleagues to join the MTA-Interfaith Caucus.

First, we attended the CUUSAN Assembly before the official start of GA! UU Justice Florida and Martha Kirby from University UU in Orlando started with the CUUSAN Annual Assembly (Coalition of UU State Action Networks). This is a great annual event for all involved in social justice in their state networks—or for those who may want to be involved. Watch the **Powerpoint presentation** from that assembly (it's a long one—102 slides!!) including a brief slideshow from 8 networks (Scroll down to slides 34-43 to see UU Justice Florida's display.) In addition, two networks created their own videos: **North Carolina** and **Maine**.

We participated in the Mini-Assembly on the Draft Statement of Conscience (SOC) for the 2016-2020 Congregational Study Action Issue "The Corruption of Our Democracy" on Thursday with a series of proposed amendments. Although many were not adopted because they were considered too detailed, we persuaded the full assembly (of 2600+ delegates) on Friday to adopt the first two unincorporated amendments and pass the final strengthened Statement of Conscience.

Pressing the assembly to pass the Statement of Conscience to work to OVERTURN corporate constitutional rights and money as speech; 99% voted YES!

The final Statement of Conscience will be posted on the UUA website by early July.

NEXT STEPS—UU congregations nationwide:

Will you join the UUA, UUSC (UU Service Committee), and UUJEC (UUs for a Just Economic Community) in support of Move to Amend and 1) pass a resolution for Move to Amend and 2) encourage your members, friends and interfaith partners to join the Move to Amend Interfaith Caucus to address the urgency of the existential threat of climate change? Download the <u>model resolution</u> for UU congregations of all states.
